END-USER LICENSE AGREEMENT ('LICENSE')

Description of Software ('the Software'): **chirosuite**

BEFORE USING THIS SOFTWARE, CAREFULLY READ THE FOLLOWING TERMS AND CONDITIONS. INSTALLING, COPYING, USING OR OPERATING THIS SOFTWARE INDICATES YOUR ACCEPTANCE TO THESE TERMS AND CONDITIONS.

This End-User License is a legal agreement between you and Sunbaked Software Inc. for the software product identified above, which includes computer software and may include associated media, printed materials, 'online' or electronic documentation and support services related to the same. If you do not agree to the terms of this license, you may not use the Software.

1. Licensor

This license is being granted by Sunbaked Software Inc. ('Sunbaked'), a company incorporated in the Province of Alberta, Canada.

2. License Grant

Sunbaked grants you a non-exclusive, non-transferable right to use this Software including any updates thereto provided to you by Sunbaked. You agree you will only copy the Software into a machine-readable or printed form as necessary to use it in accordance with this license or for backup purposes in support of your use of the Software.

3. Term

This license is effective for the term of the service period you have purchased (the 'Purchased Service Term'), unless terminated earlier as provided in this license, and only with respect to those computers covered by the Service. At the completion or early termination, the provisions of sections 5, 7, 8, 11, 12, 13, 15 and 16 of this license will survive and you will destroy the Software and all copies.

4. Termination

This license is terminated automatically at the end of the Purchased Service Term. You may terminate this license at the end of your Purchased Service Term by destroying the Software and all copies. Sunbaked may terminate this license, without notice, if you fail to comply with any term or condition of this license or upon the termination of any Support Services provided to you by Sunbaked, its affiliates or authorized service providers in connection with this Software.

5. Ownership of the Software

Sunbaked may have patents or pending patent applications, trademarks, copyrights, trade secret rights or other intellectual property rights covering the Software and all materials delivered to you along with the Software. You acknowledge that the Software and such materials are the property of Sunbaked and that the only rights you have with respect to the Software and related materials is the right to use them in accordance with the terms of this license. The Software is protected by applicable intellectual property laws and international treaties. You

(a) acknowledge that no title to the intellectual property in the Software is transferred to you, and

(b) confirm that any copies of the Software you make will contain the same proprietary notices, which appear on and in the Software.

6. Modification; Reverse Engineering

You agree that you will not, and will not attempt to

(a) modify any part of the Software or

(b) decompile, reverse assemble, reverse engineer, translate or disassemble any

part of the Software.

7. Other Restrictions

You may not

- (a) transfer, rent, lease or sublicense the Software,
- (b) make any telecommunications data transmission of the Software, or
- (c) unless all CPUs or users are properly individually or site licensed by Sunbaked, permit use of the Software in a computer service business, network, timesharing, multiple CPU or multiple user arrangement.

8. Software and Service Limitations

The Software is provided to you 'as is' without warranty of any kind, either express or implied. Sunbaked cannot guarantee that the Software will meet your other requirements or that the operation of the Software will be uninterrupted or that the Software will be error-free. Sunbaked may provide you with services related to the Software ('Support Services') for the Purchased Service Term. Use of the Support Services is governed by the following provisions and terms:

- a) Customer Assistance. At the option of Sunbaked, Sunbaked, its affiliates or authorized service providers will provide Support Services including either correcting errors in the Software or helping you work around or avoid the errors.
- b) No Warranties. Sunbaked does not guarantee that Support Services will be provided without interruption. Sunbaked does not guarantee quality or timeliness of Support Services, and will not be held liable for any losses in the event of a service failure.
- c) Term. Support Services will remain in full force during the Purchased Service Term unless earlier terminated pursuant to the provisions of this license.
- d) Restrictions. Sunbaked reserves the right to withhold Support Services in the

event that failure of the Software has resulted from accident, abuse or misapplication.

e) Account Misuse. In no event will Sunbaked be liable for any unauthorized use or misuse of the Software, host key or password. It is your responsibility to protect the information provided to you by Sunbaked.

11. Export Restrictions

You acknowledge that the Software licensed hereunder is subject to the export control and regulations of Canada, and any amendments thereof. You confirm that with respect to the Software, you will not export or re-export it, directly or indirectly, to any countries that are subject to Canadian export restrictions. You further acknowledge that the Software may include technical data subject to export and re-export restrictions imposed by Canadian law.

12. Confidentiality

The term 'Confidential Information' means any information or material, which is proprietary to Sunbaked, whether or not owned or developed by Sunbaked, which is not generally known other than by Sunbaked, and which you have obtained through Sunbaked. Confidential information includes without limitation: trade secrets, technical information, product design information, database scripts, database schema, source code and/or object code, copyrights and other intellectual property associated with the Software.

You understand and acknowledge that the Confidential Information has been developed or obtained by Sunbaked by the investment of significant time, effort and expense, and that the Confidential Information is a valuable, special and unique asset of Sunbaked, which provides Sunbaked with a significant competitive advantage, and needs to be protected from improper disclosure. You agree to hold in confidence and to not disclose the Confidential Information to any person or entity. This specifically includes allowing other vendors access to our database structure which would allow them to see how we structure & store our data.

13. Severability

In the event of the invalidity of any provision of this license, the parties agree that such invalidity shall not affect the validity of the remaining portions of this license.

14. Governing Law and Jurisdiction

This license is governed by the laws of the Province of Alberta, Canada, and the laws of Canada applicable therein. You irrevocably and exclusively agree that any dispute in respect of this license will be commenced and heard only in courts of Alberta and all courts having appellate jurisdiction there over.

15. Entire Agreement

This End User License Agreement along with the Terms and Conditions of Service set forth the entire agreement and understanding between you and Sunbaked, and supersedes any prior agreement or understanding, whether written or oral, relating to the subject matter of this license.

16. Consumer Protection Laws

The Software is intended for commercial purposes only. You represent in accepting this license that you have reviewed the contents of the website in relation to the Software and agree that the disclosure provisions and other requirements of the Alberta Fair Trading Act and Internet Sales Contract Regulation have been complied with. You further acknowledge and agree that all required information pursuant to such legislation has been prominently displayed in a clear and comprehensible manner and made accessible in a manner that ensures that you have accessed the information and that you are able to retain and print the information should you desire.
